Rosa's Covid-19 Response Fund – Small Grants

Application Guidance

Rosa supports women's organisations to make the UK a fairer and safer place for women. This time of unprecedented crisis presents a challenge like no other for women's organisations and our collective journey towards gender equality. 'We know that existing inequalities mean that the impact of Covid-19 will hit women the hardest, especially women who are already vulnerable. Rosa is here to help women's organisations respond. We are working hard to share information, develop resources and provide responsive funding both in the short and longer term.

We know the situation is uncertain and we want to ensure our response is relevant. Our immediate action is to launch a fund to provide small grants. However we will be continually reviewing the landscape for women's organisations to plan longer term grant funding of larger amounts.

We are also going through a process of reviewing and adapting the wider development support we offer which includes mentoring, training and information webinars. More to follow!

Small Grants

This is our first stage of funding support in response to the Covid-19 crisis. We have been listening to the UK women's sector to understand more about how it has been impacted. We know that you need a broad range of support, we know that fundraising is a huge worry, we know that support for your staff/volunteers and the women you support is at the top of your priority list. We know that you are worried about the situation now and in the future and we know that you have been working hard to adapt. We also understand many of you are trying to increase the level of support you provide to respond to increased demand. We

have always recognised that women's organisations across the UK work in hugely varied ways to help make the UK a fairer and safer place for women and girls. We want to help women's sector organisations through this crisis.

Programme Aims

This first stage response fund aims to provide quick and straightforward grants of up to £10,000 to specialist 'by, for and with' women's organisations across the UK. There are some very basic eligibility criteria, however based on what we now know, we think it is vitally important that this is an open call for UK women's organisations to apply for what they identify as a short term funding need that has arisen as a result of the Covid-19 crisis. We will support charitable women's organisations whose work fits under one or more of Rosa's four pillars (leadership and representation, safety, health and wellbeing and economic justice).

What sort of work will be supported?

Here are some examples of the types of costs we cover:

- Costs that enable you to meet the immediate needs of the women and girls you support.
- Costs that enable you to meet the immediate needs of your staff and volunteers.
- Costs that enable your organisation to adapt your work to continue to reach women and girls during this time. Costs already incurred as direct result of the Covid-19 crisis will also be considered.
- Costs to free up capacity to fundraise.
- Costs that support the short term survival of your organisation.
- Costs that support your organisation to better connect with the sector or with wider stakeholders.

This is by no means an exhaustive list and we are open to hearing what your short term funding needs are.

How much can I apply for?

Grants of between £1,000-£10,000 are available for a period of up to six months.

Who can apply?

If you meet **<u>all</u>** of the following requirements, you can apply for a grant:

- Your organisation is non-profitable and run predominantly by, for and with women. You do not have to be a registered charity, but your activities must be charitable, legal and for the benefit of women.
- You have a written governing document, e.g. a constitution or set of rules.
- You have a governing body with at least 3 unrelated members.
- You have a UK-based bank or building society account in the name of your organisation.
- Your bank or building society account has at least 2 unrelated signatories.
- You have been active for at least one year and can produce annual accounts for a whole year.
- You have an appropriate safeguarding policy in place (every organisation that delivers charitable activities has a duty to safeguard volunteers, staff members, participants and donors).

Rosa particularly welcomes proposals from women's organisations that:

- Address the critical needs of women and girls that miss out the most, including: marginalised populations, BME women, LGBTQ+ women and girls, women and girls with disabilities, older women, homeless women, survivors of gender violence, women in prison and ex-offenders, and other underserved and disadvantaged groups of women.
- Operate in less economically resilient towns, cities and rural areas within the UK.

We anticipate a high number of applications to this fund, therefore we may decide to prioritise applications for funding. This may be smaller organisations that have less capacity to fundraise and organisations based outside of London due to the significant work of the London Community Response Fund.

What cannot be funded?

We are unable to fund the following types of activities:

- responsibilities of statutory agencies
- profit-making work

- party political activity
- activities promoting religious beliefs
- work outside the UK
- applications from individuals
- overseas travel
- interest payments on loans
- building purchase and improvements

How to apply

To apply, please complete our brief <u>online application form</u> outlining how you will use the funding. Applications will be considered from **Friday 5th June** on a rolling basis. We will do our best to notify applicants of the decision within approximately **two weeks** of submitting an application. If we receive a very high volume of applications we will notify you if the response will be longer.

We are crowdfunding to support these grants and have a limited amount to award. If this fund becomes heavily oversubscribed, we may need to suspend applications.

We urge you to contact us if you have any queries about submitting an application. The best way to contact us at this time is to send an email to info@rosauk.org. Please insert 'Covid 19 Small Grants' as your email subject and provide your organisation, contact name and contact number if you would like to speak to someone.

Once you have read this guidance click and select 'new applicant?' to start your application. If you have applied previously to Rosa, please use your existing login details to log in and start a new application.

If you start your online application, but are unable to complete all the required information, don't worry, you can simply save your form and come back to it at a later date. To access your form again, <u>use this link</u> then log in using your email address and the password you created.

If you forget your password you can create a new one by clicking on 'Forgot Password?' and following the instructions.

We are keen to ensure the application process is as simple and straightforward as possible. Therefore women's organisations that have received funding from Rosa since January 2018 will only need to provide limited information – you will be prompted in the application form where this is the case.

We are only able to accept one application per organisation and can't accept repeat applications.

If you are successful

We will write to you with a funding agreement which outlines the terms and conditions of the grant. A grant payment will be made shortly after we receive your signed agreement. At the end of your grant you will need to complete a short monitoring form to tell us how the grant helped.

	 You are a women's organisation. Rosa defines 'women's organisations' as those which are run by, for and with women. This means your organisation should have the principal objective of working with women and girls and where the majority of the organisation's beneficiaries are, and will always be, women and girls.
	 You are a charitable organisation - your organisation need not be a registered charity, but your purposes and activities must be charitable and legal.
	• You have a written governing document, such as a constitution or set of rules.
	 You have a governing body with at least 3 unrelated members.
	• You have a UK- based bank or building society account in the name of your organisation.
	• Your bank or building society account has at least two unrelated signatories.
	• You have been active for at least one year and can produce annual accounts for a whole year.
	• The work for which you are seeking funding does not promote religious belief.
	• The work for which you are seeking funding will take place in the UK.
	• The work for which you are seeking funding does not have a party political nature.
