## About us

Rosa is a grant making charity that funds grassroots women's organisations, to help make the UK a fairer, safer place for women. We are a small and friendly team that is supported by a wider group of freelancers. We have an office base in London and our team and assessors are based across the UK. **About the role** We are recruiting for our pool of independent UK assessors, who will assess the funding applications that we receive at Rosa. Our freelance assessors are an important part of Rosa and our grant application process, providing independent insight and objective assessments of the applications that we receive. Your work would play a key role in supporting us, to identify those organisations that will receive funding from Rosa.

We are keen to have a diverse pool of assessors, who will bring an array of their unique experiences to our grant making practice. We are particularly interested in recruiting people from black and minority ethnic backgrounds who can support us on our upcoming Black and minoritised fund which will be launched in September 2021. We envision calling upon new assessors to support this fund in November 2021. We are also interested in recruiting people with lived experience from marginalised communities, and those based in Northern Ireland, Scotland and Wales. Previous experience of grant assessment work is desirable, but not essential.

We will offer you training so that you can undertake this role and you will gain experience of grant making with an innovative funder. You will also get the opportunity to interact with a wide range of charities and community groups, working in the women and girls sector across the UK.

We expect to have 2-3 funding rounds per year, but we will only contact you when we anticipate the launch of a fund. You will need to be responsive and flexible in arranging assessments within the proposed fund timeline. Specific responsibilities include:

- Make recommendations on applications, including identifying relevant conditions, where needed.
